Tree Authority denies it felled trees for Metro 7

The Metro 7 line extending from Dahisar (east) to Andheri (east) on the Western Express Highway (WEH) has faced obstacles right at the start of the project due to felling of trees. Residents across the city have claimed that the Mumbai Metropolitan Region Development Authority (MMRDA) and Brihanmumbai Municipal Corporation (BMC) have violated the Bombay High Court's order which directed the BMC not to cut or destroy any trees on the WEH.

Over six trees were axed last week at the WEH at Malad (east) for the Metro 7 project. When the residents witnessed the felling of trees, they informed the activist who then referred to the court's order. On February 3, 2016, Zoru Bhathena, a Khar resident, received the court's direction in response for the public interest litigation that he had filed against cutting of trees on the WEH.

The Bombay High Court had then directed the BMC by passing an order which stated that the corporation

should ensure that trees on WEH are neither cut nor de-

Bhathena said, "The court's order is still valid as there is no new direction given in this matter. And according to this order, not even one tree on the WEH can be harmed." On the highway stretch at Kandivali (east), the onsite Metro workers informed that trees were cut in that area too and transplanted to Sanjay

Gandhi National Park at Borivali. But the specific number of trees cut at that spot was unknown.

PRK Murthy, Director (Projects) Metro of MMR-DA, said, "This Metro line is managed by MMRDA. We have cut trees only after taking the permission from the Tree Authority of the BMC.

On the contrary, the Tree Authority has denied felling of trees for this

project. Jitendra Pardeshi, senior tree officer of the Tree Authority, told the Free Press Journal, "We have granted permission for cutting of trees on the WEH but till now no tree has been cut over there. Till now, felling of trees has not taken place at the WEH." On the court's order, Pardeshi said, "The court's order was for a different purpose and it is not related to this issue."

3.9kg gold bars seized

Customs officials have recovered total 3994 grams gold bars and crude gold chain worth over Rs. 1.21 crore. In the first case they arrested one lady passenger Fathimath Raseena Mohammed (29) who was carrying 14 gold bars of 10 tolas each weighing 1,632 grams. Its market valued was Rs. 49.51 lakh.

"We intercepted her at Chhatrapati Shivaji International Airport in Mumbai on February 13 when she arrived from Dubai by Air India flight number AI 984. Mohammed was very confident when we intercepted her. She speaks fluent English. She had cleverly concealed these gold bars beneath her upper body garment worn by her," said a customs official.

CBI charges 10 cops with unnatural sex

The Central Bureau of Investigations (CBI) on Monday informed the Bombay High Court that it has invoked the charges of 'unnatural sex' against the 10 police officers of the Wadala Railway Police, accused of killing a minor boy in their custody.

A division bench presided over by Justice Ranjit More Justice Shalini Phansalkar - Joshi was hearing a petition filed by the father of the deceased Agnelo Valdaris, who was found dead on the railway tracks near Wadala in April 2014. His father has alleged his son along with three of his friends, was picked up by the Wadala Rail-

way police on charges of robbery. It is the prosecution's case that the police officers continuously tortured and mentally harassed the youngsters and even forced them to do 'unnatural sex' with each other. When the matter was called for hearing on Monday, CBI's counsel Hiten Venegaonkar informed the bench that the agency has invoked stringent section 377 of the Indian Penal Code, which deals with unnatural sex. He also informed the bench that the CBI has also invoked several sections of the Protection of Children from Sexual

Offences (POCSO) Act. Venegaonkar also told the bench that the CBI has prepared its supplementary chargesheet and would be filing the same soon in the concerned court. This comes in accordance to the submissions made by advocate Yug Chaudhary, the counsel appearing for Valdaris's father. In a previous hearing, he had sought invocation of section 377 against all the 10 policemen, who are booked by the CBI.

He had told the bench that the agency in its FIR booked the police officials on charges of murder, unnatural sex, kidnapping and falsifying evidence along with several relevant sections. He also told the bench that when the agency filed its chargesheet in January, it charged the accused under criminal conspiracy and other lesser charges.

No relief to NCP leader

Observing that corruption is a 'serious' crime and must be dealt with strictly, the Bombay High Court on Monday rejected the bail application moved by former Member of Parliament (MP) Devidas Pingle.

Pingle, a leader of the Nationalist Congress Party (NCP) and chairman of the Agriculture Produce Market (APMC) was arrested by the ACB under charges of corruption and disproportionate assets case. The agency had seized total of Rs 57 lakh by intercepting a car in Nasik in October last year. The agency's case is the cash was being carried by three men working for Pingle and was withdrawn from the banks on his behest.

5 held for kidnap, murder of bizman who did not return ₹39 lakh loan

Five persons were arrested by the crime branch unit-3 of Mumbai in the kidnap and murder of a businessman due to non-recovery of loan of Rs.39 lakhs borrowed from the arrested person.

The arrested persons are Satyakumar Bhagirathi Panigrahi alias Dhiren Kumar Pillai (37), Sandeep Popat Kumbhar (39), Kapil Prabhakar Jadhav (32), Mallya Jagvandu Barik (33) and Akhlaq Irshad Hussain Khan alias Chand (44).

The police said that the plot for revenge to murder Sachin Narayan Mohite (36), was hatched since Panigrahi understood that they

were cheated by the businessman. Panigrahi had threatened Mohite before that he should return their money else he would face severe consequences.

The incident occurred on

July 11, last year when Mohite, the owner of a marketing company was kidnapped and murdered since he was not able to pay the loan amount of Rs.39 lakhs that he had borrowed from Panigrahi and his accomplices. Since the arrested persons were not getting back their money, Panigrahi asked him to meet him at a restaurant near Mira road station. The victim Mohite was accompanied with a friend.

"After kidnapping Mohite, Panigrahi and his accomplices drove to Manor in a car and thrashed Mohite and his friend. They then asked Mohite's friend to leave. They threw Mohite sis. into Surya creek where he passed out due to bashing .They disposed off the body at Surya creek at Palghar on July 11, "said Sunil Mane, Senior Police Inspector, crime branch.

"Police Inspector, Sanjay Nikumbhe attached to crime branch unit-3 had received a tip off that Panigrahi was spotted at Lower Parel. We dispatched a team and arrested Panigrahi on Wednesday. During interrogation, Panigrahi revealed the names of his accomplices and their whereabouts, "added Mane.

plaint was filed in this case, the arrests were made only on the basis of human intelligence and technical analy-

The locals had found Mohite's body at Vaitarna creek at Padgaon on July 15 last year. They had informed the Saphale police about the discovery of the dead body. An Accidental Death Record was then registered by the Saphale police. However, for seven months, the accused managed to escape from the police.

The prime accused Panigrahi was wanted for several cases of theft, attempt to murder and murder in Mumbai and Thane. The accused have been remanded to police custody until February 17.


